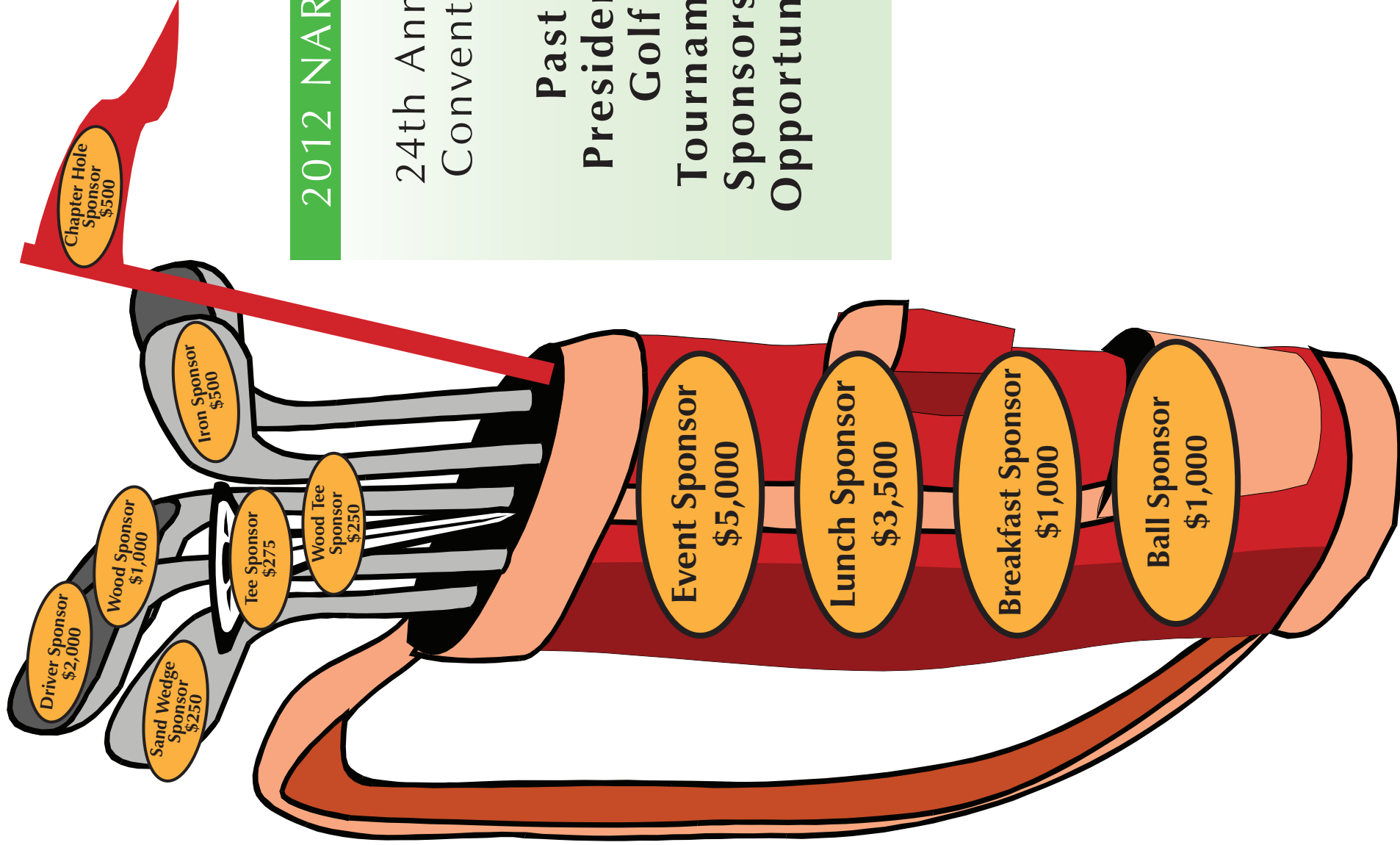
THIS YEAR'S CHARITIES
