SIX: The period of duration of this corporation is perpetual.

SEVEN: The classes, rights, privileges, qualifications, and obligations of members of this corporation are as follows:

This corporation shall have three class of membership. Member.

- A "Member" shall be an individual who is employed as a property manager or is actively seeking such employment. For the purposes of this Section, a property manager is defined as a real estate licensee in the state of Washington who is actively involved in the full-time management of residential properties either as an employed, subcontractor, real estate sales person, broker or designated broker.

 1. Acceptance into Membership: An applicant for membership in a Chapter shall first be a member of the National Association of Residential Property Managers. A member of the National Association may be a member of more than one Chapter membership.
- 2. Voto: A member shall be eligible to vote in person at the Annual Meeting of the Chapter in which officers are elected. The vote shall be done in person. A member shall be eligible to vote at all meetings of chapter committees, if any, upon which the Member serves.

An "Affiliate Member" shall be a business entity, which provides products or services to residential property manager. Requirements relating to acceptance of Affiliate Membership and suspension of Affiliate Membership and suspension of Affiliate Membership shall be identical to those specified for members except for the following:

- 1. Vote: Affiliate Members are not eligible to vote in general elections; however, Affiliate Members can serve in advisory positions to the Executive Committee or as Chapter committee Chairperson or Chapter Committee Mambers.
- 2. A Chapter Affiliate Nember does not have to be a vendor affiliate member of the National Association.

An "Honorary Chapter Membership" shall be bestowed upon individuals or affiliate members who, in the opinion of the Executive Committee, have rendered or continue to render distinguished services to the

Association or the profession of property management. Monorary Chapter Rembers shall pay no chapter dues or other assessments, and shall be eligible to participate in the usual activities of the Association, except they shall be ineligible to vote, hold office or serve as a mamber of the executive committee unless they are current members in good standing in the Chapter and National Association, as appropriate.

Additional provisions specifying the rights and obligations including the method and payment of annual dues if required shall be contained in the By-Laws of this comporation pursuant to, and in accordance with, the laws of this state.

EIGHT: Any additional provisions for the operation of the corporation are as follows:

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence inegislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Note the standing any other provision of these Articles, this

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exampt from federal income tax under section 501(c)(3) of the internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the internal Revenue Code.

In any taxable year in which this corporation is a private foundation as described in Section 509(a) of the Internal Revenue Code, the corporation 1) shall distribute its income for said period at such time and manner as not to subject it to tax under Section 4942 of the Internal Revenue Code; 2) shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code; 3) shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code; 4) shall not make any investments in such manner as to subject the corporation to tax under Section 4944 of the Internal Revenue Code; and 5) shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code.


